MINUTES OF MEETING: January 14, 2015

Meeting was called to order by Chairman Bob Garmon at 6:00 pm at the Valparaiso Lakes Area Conservancy District's office.

Don made a motion to accept the minutes, Rolando seconded it. Motion carried. 6-0.

Financial Report

Nancy gave her report on the financial reports and the claims. Don had a brief question on the HSA distributions. Nancy made the motion to accept the claims and fund reports, Bob seconded it. Motion carried. 7-0.

The floor was opened up to accept public input on the additional appropriation for \$57,000 for land acquisition. Tom Banaszak questioned if there was a clear title which Dave responded that it was guaranteed by the Meridian Title Company. Bob closed the public comment section.

Tom made the motion to establish the appropriation and move it into the newly formed line item "land acquisition", seconded by Nancy. Motion carried 6-0.

General Manager's report.

Request permission to order materials for Leisure.

If \$20,000 is approved for sealing manholes, I will seek quotes.

JPR options for El-Naggar's sewer extension just arrived. A 13 home option and a 62 homes option.

Home in Wild Rose was checked for soil erosion violations. Sub contractors had run over the fencing. Lisa was contacted and new socks were there the next day.

Looked at several vans and pricing is all over the place. Used vans are not common. Laura's education cost. \$2300 was approved last year for the fall. She has found out the same amount for the spring classes. A status report will be required. MS4 audit coming up.

Need a motion from the Board that Christmas days off were from 24th and 25th to the 25th and 26th of December. Mickey so moved, Rolando seconded it. Motion carried 6-0.

Tom asked that the Holidays be reviewed by the Board every year more probably by the personnel committee.

Burlington Beach Road improvement project. \$11,100 appraisal for the frontage property including about a portion of a sidewalk.

There will be an annual meeting Feb. 18th and the floor will be opened up to any public comment. Then within 20 days Dave will file with the courts our financial reports. Dave will send in to the papers notice of the annual meeting.
