Lake Enhancement – Flint Lake has been sprayed. Notices were mailed out. 14 signs posted at entrances and notices were posted on the docks as agreed. The curly leaf pondweed is dying out.

New van is ready in the morning.

Bicentennial Nature Trust – Need to put together a rough educational plan. Postponed until the fall.

Nothing on Sunny Lane. Dave putting letter together. Mickey will hand deliver and Nancy agrees to go along.

Mickey mentioned a pothole with a valve box in it.

Bob handed the gavel back to Tom.

Don made a motion to ask JPR for the offer for a free study. Tom seconded it. Motion carried. 6-0.

0 meter change outs, 21 delinquent turn off all back on. 25 locates and 3 seasonal turned on.

Laura had given out her cost factors for Mrs. Liechty. Water drained to the street. Customer to be given 50% of the cost on sewer only of \$340. Rolando made the motion. Nancy seconded. Motion carried 7-0.

Customer appreciation day. Bob M. reported about 60 customers. Mr. Matthews and Mr. Schiller won the rain barrels. More than a third of the seedlings were handed out. North Valpo Neighbors newsletters, it was determined that not all the customers would be served therefore it was rejected by the committee.

Mr. Wagner was given the floor to report on the property survey. Some parking in the front. Existing office divided into staff and public areas. Shop remains where it is. Staff parking in back. New pole barn on the Button lot in NE corner. Parking, storage areas, entrances were discussed.

Attorney's report

Dale received the auditor's tax certificate. It will be directly deposited in the amount of \$132669.58 how it was divided does not seem right and Dave and Dale will check into this.

The 2016 budget starts July 16th.

This will be the first year where we do not place legal advertising in the newspapers. The staff sent Dave a delinquent account in \$623 Mallory Martin. The Board determines that she be placed in the disconnect policy and Dave will inform her and she may attend the next meeting to plead her case. Bob so moved, Rolando seconded it. Motion carried 7-0.

Sunny Lane -

Dave needed to add contact information for the resident to return to us as to how we can contact us. Mickey wanted a change in the letter that makes it a bit clearer as to the annexation requirement. Dave will make the change.

Dave explained the status of Cardinal Lane to a realtor. Neighborhood Utilities owned the roads and transferred them to Kilmer-Frazier. When the utility was purchased, the roads went with them but VLACD did not want them, the County did not want them. According to County records VLACD still owns the roads. To help the realtor sell the property we may need to offer a prescriptive easement.

Bob motioned to purchase the Cook's property with the additional appropriation. 1/2 down with three years to pay balance unless the grant come through. Tom seconded. Motion carried 6-1.

Don moved the rainy day fund be used. Bob seconded it. Motion carried. 6-0-1. Long Lake –Don was to go door to door but got caught up helping his son. It was discussed what to say. Mickey suggested the possibility of helping the West Long Lake property owners financially. Several different thoughts came up. Dave agreed to look at different scenarios to finance the area.

Bob closed the meeting at 7:30 pm.
