MINUTES OF MEETING May 11, 2016

Meeting was called to order by Chairman Bob Garmon at 6:00 pm

Mickey moved to approve the minutes. Tom seconded it. Motion carried. 5-0.

The Financial Committee's report.

Mickey moved to approve the claims and accept the financial statements. Seconded by Bob. Motion carried 5-0.

Nancy suggested it should be put back the way it was. Bob brought up that it was full of potholes and the grade is wrong. Nancy suggested that the ditch on Evelyn Duncan's property be put back in. James Holland just wants the road lowered back to the way he believes it was. Bob asked if anyone knows who has a grader. Only the County has a belly pan style one. Mickey asked what this might cost to install storm drains. Bob M. remembers it at \$2400 to \$2700. Mickey fells that storm water is our charter but not the road work. Bob asked are we looking at roads or drainage. Mr. Holland wants the road graded out, not so much the drainage, and put Duncan's ditch back in. There were more discussions about different aspects. Tom mentioned that taking the stone out will that cause other problems?

Nancy motioned to install the drainage not to exceed \$3000. Mickey seconded. Bob M. asked if there was a problem if he called the County to grade the road. Motion carried 5-0.

Bob decided to go ahead and award the bid for the office.

Dave started the bid award process. Both Dave and Brent Wagner have studied the bid and found Total Development Construction Inc. to be the lowest and most responsive bidder and suggest the Board award the office remodel contract at \$256,850 for the base amount and \$7500 for the new windows. Mickey so moved for both the base bid and alternate 1 at a cost of \$264,350.00. Nancy seconded it. Motion carried. 5-0. Dave stated that Tim wanted to start on the 15th of May. The inspection process was part of the original Wagner contract along with pay request forms.

General Manager's report.

No new homes. A house scheduled on Sumac does have a storm water problem. LARE contracts are difficult to find. Dave believes the successful bidder issued the contracts. Bob M. does not remember any coming across his desk but Dave believes otherwise. Dave will look for one. Bob M. reminded everyone there are two successful bidders Lake and Pond Biologists for Flint Lake and the AVMP and Clarke Aquatics for Long Lake.
