The question on 511 Long Lake Lane and the soil erosion/seawall was discussed. It was determined that the environmental committee will view the site before any determinations are made. The committee will meet Nov. 19 at 8:30 am. Homeowner has been notified of our concerns about soil erosion. Homeowner had the area seeded and strawed. The hill leading down need additional work.

Attorney's report

Elections coming up for Tom Area 7 and Nancy Area 3 both 4 year terms. Walt will be up for the balance of the three years of Bob Garmon's term. Petitions due by end of business `Dec. 1st. Nancy's petition is in and signatures approved.

The Walden loop is on hold while an easement encroachment has been discovered and needs to be rectified. Dave reported that Brett has sent a contract for the Loop at \$10,600 plus \$200 out of pocket. Mickey moved to accept this, Tom seconded it. Motion carried 7-0.

The City Council denied the Spectacle Lake annexation. 4-3. It will now probably go to the County for approval.

Dave suggests we contact the county to keep us informed of any annexation movements. Mickey moved that Bob keep tabs with Mike Novotny the storm water management for Porter county.

The County Park Superintendent has also been contacted by local residents to acquire the property.

There needs to a contract with Bob Garmon if he continues to fill in for Bob M. when he goes on vacation and if we need to pay him something. Referred to personnel committee.

The idea to vacate Lowenstein Lane has been rejected.

Floor to Tom – Talked again about storm water into the District from the annexation.

Transfer resolution. \$900 to be moved around. Tom moved to approve it. Rolando seconded it. Motion carried 7-0.

(Quick break for pizza then Strategic Planning continued.)

Discussions included septic tanks, annexations of Sunny Lane, Johnson Road, North Woods, West and East Long Lake. These were titled "Growth".

Nancy will re-write the Strategic Plan with current rankings.

Additional thoughts - looping projects, capacity costs.
